

## **Wiz Event Terms and Conditions**

Your registration for or participation in any Wiz, Inc., including any affiliate of Wiz, Inc. ("Wiz", "we", "us" or "our") hosted event (the "Event") shall be deemed to constitute your full acceptance of these terms and conditions ("Terms").

By registering for the Event, you acknowledge and understand the nature of the event and agree to assume all risks associated with attending and participating in the Event, including the risk of injury and/or property damage. You acknowledge that your attendance and participation is entirely voluntary.

### **Event Rules**

- Event registration is subject to availability and may close earlier than the posted deadline, as determined in our sole discretion. We reserve the right to cancel the Event at any time for any reason, including, but not limited to, speakers' unavailability or for health and safety reasons. We may also change the event location ("Venue") and the Event program at any time in our sole discretion.
- To register for and attend the Event, you must provide certain identifying details. We will handle your personal information in accordance with our [Privacy Policy](#).
- Your entry to and participation in any Event shall remain at our sole discretion. We may, at any time, restrict or prohibit you from the Event, including where we reasonably believe that you: (i) have breached or attempted to breach any term or condition relating to the Event as notified to you; or (ii) have engaged in any abusive, offensive, disreputable or violent behavior or supplied false or misleading information to Wiz.
- Event tickets are non-transferable, may not be duplicated and may only be used by the registered individual as permitted under these Terms.
- Wiz is committed to promoting a culture of integrity, accountability, and ethical conduct. We expect all Event attendees to adhere to high ethical standards and to avoid engaging in any activity that may suggest impropriety.

### **Health and Safety**

- You must comply with all health and safety guidelines, provided by us or the Venue concerning your attendance of the Event as well as any applicable legal or regulatory requirements. Failure to comply with any direction given may result in you being removed from the Venue or barred from the Event.
- You must take all reasonable steps to ensure your own health and safety when attending the Event or participating in any of the activities forming part of the Event. Any behavior or act or conduct by you which we or the Venue considers to pose any medical, security or safety risk (including without limitation any abusive behavior, physical or psychological) will lead to your immediate removal from the Venue and prohibition from further participation in the Event.
- You hereby acknowledge and agree that your attendance at and participation in the Event is at your own risk.

### **Filming and Image Rights**

By attending the Event, you grant us, our affiliates, and our independent contractors the right to record, film, photograph, and capture your voice and image in any media at the Event (the "Recordings"). You irrevocably grant to Wiz and its affiliates, agents, employees, and assigns an irrevocable, nonexclusive, perpetual, worldwide, royalty-free right and license to make the fullest use, including without limitation, to reproduce, modify, distribute, publicly display, and translate, for any purpose relating to our business, all or any part of the Recordings. Such use includes, for example, the production and release of promotional ads of, or other marketing materials related to Wiz's or its partners' products, services, and brand. We may edit the Recordings, use them alone or together with other information, and allow others to use and disseminate them. To the maximum extent permitted by law, you waive any moral rights you may have in the Recordings.

#### Limitation of liability

WE AND OUR AFFILIATES AND PARTNERS WILL NOT BE LIABLE TO YOU UNDER ANY CAUSE OF ACTION OR THEORY OF LIABILITY, EVEN IF A PARTY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, FOR (A) INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, OR EXEMPLARY DAMAGES, OR (B) LOST PROFITS, REVENUES, CUSTOMERS, OPPORTUNITIES, OR GOODWILL. IN ANY CASE, OUR AND OUR AFFILIATES' AND PARTNERS AGGREGATE LIABILITY UNDER THESE TERMS WILL NOT EXCEED USD \$100. THE LIMITATIONS IN THIS SECTION APPLY ONLY TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW.

We reserve the right to amend these Terms at any time; therefore, you should review the most updated version each time prior to your attendance at the Event.

The laws of the State of New York, without reference to conflict of law rules, govern these Terms and any dispute of any sort that might arise between you and Wiz.
